

1. Registration

Security Printers, International Conference & Exhibition is open exclusively to security printers, suppliers to security printers, banknote issuing authorities, government authorities, law enforcement and postal authorities. All participants have submitted a detailed checklist and product samples to Intergraf's Committee of Experts. Intergraf reserves the right to refuse participation if the required criteria are not met.

2. Payment

Payment is due upon receipt of the invoice and must be made in euro. Any sum unpaid within 30 days of the invoicing date shall automatically and without notice attract interest at a rate of 1.50% per month. Payment can only be made by bank transfer and credit card (Visa, MasterCard and American Express).

3. Cancellation

In case of cancellation, the following policy will be applied by Intergraf. Cancellations made:

- after 23/01/2018 will incur a charge of 25% of the total invoiced fees.
- after 20/02/2018 will incur a charge of 50% of the total invoiced fees.
- after 27/02/2018 will incur a charge of 100% of the total invoiced fees.

Refunds will not be given for no-shows.

4. Substitutions

If you have registered and can no longer attend, another representative from your company can take your place at no extra charge, provided that you notify us in writing at least two weeks before the start of the event at securityprinters@intergraf.eu.

5. Insurance and liability

Registration fees do not include insurance of any kind. Participants carry their own risk for personal injury or loss of property, including baggage, during the conference. Intergraf is in no way responsible for any insurance claims.

6. Privacy
